PROCEEDINGS OF THE 29th GOVERNING COUNCIL MEETING HELD ON 12th JUNE 2020 AT NOIDA AT 11:00 HOURS

29.00 Welcoming the members to the 29th Governing Council Meeting.

The Member Secretary, Dr Gurulingappa M Patil, welcomed the Chair, members of the Council and Special Invitee to the meeting.

In the absence of His Holiness Mahaswamiji, Chairman of the Governing Council of JSSATE, Noida, Dr. C G Betsurmath, Executive Secretary chaired the meeting.

The Member Secretary introduced the following new members to the Governing Council:

- 1. Dr H G Shivakumar Principal, College of Pharmacy, JSSATE-N -Member
- 2. Dr. Surinder Singh, Vice Chancellor, JSSAHER, Mysuru-Special Invitee

After seeking permission from the Chairman, the agenda was taken up for discussion.

29.01 To Read and Record the Proceedings of the 28th Governing Council Meeting held on 20.11.2019.

The Member Secretary started with the Proceedings of 28th Governing Council Meeting held on 20.11.2019. He informed the Council that the Proceeding of 28th Governing Council Meeting was circulated among all the members of the Governing Council on 16.12.2019 and no comments or suggestions were received.

The Council accepted the Proceedings as read and recorded.

29.02 Action Taken Report on Proceedings of 28th Governing Council Meeting. The Member Secretary explained the Action Taken Report of the 28th Governing Council Meeting held on 20.11.2019.

Resolutions

• Conduct of International Conference:

A two-day International Conference on Intelligent Control and Computation for Smart Energy and Mechatronic Systems (ICCSEMS-2020) is scheduled to be held at JSSATE, Noida on March 20-21, 2020.

Action

The Member Secretary informed to the Governing Council that in order to take preventive measures to combat the threat of the Novel Corona Virus, ICCSEMS-2020 which was scheduled to be held on 20-21 March 2020 has been postponed to 25-26 September 2020. The International Conference will be conducted through online mode. The Member Secretary briefed the progress of the work done for ICCSEMS-2020.

Dr. B. Suresh, Pro Chancellor, JSS AHE&R, Mysuru asked the reason of delay for conducting the International Conference, as it is scheduled through online platform and there is no need of additional preparation.

The Member Secretary has been asked to conduct the International Conference at the earliest and the brochure of the International Conference is to be uploaded on the College website immediately.

29.03 Academic Report:

- 1. Approved intake and students admitted in AY 2019-20:
 - (a) The Member Secretary presented the approved intake of the Academy in the AY 2019-20. The annual intake of the Academy in the AY 2019-2020 is 1074.
 - (b) The Member Secretary presented the details of UG and PG students admitted in the Academy during the AY 2019-2020 including lateral entry admissions. Total admission the Academy for UG program is 93.85% and PG program is 56.63%.
 - (c) Total strength of the students in the Academy during the AY 2019-2020 is 4388.

The Governing Council noted that the admission in various M.Tech programs offered by the Academy is decreasing every year and they asked the reasons.

The Member Secretary said that owing to following reasons the admissions for M.Tech. Programs are low:

- (1) Placement after B.Tech. is very good.
- (2) JSS ATE, Noida students work hard for clearing GATE for joining PSUs and UPSC, CAT and other competitive exams.
- (3) Few students are interested in PG as job opportunities for PG Degree holders are limited.

Sri . B K Gupta, CAO, JSSATE, N said that regular M.Tech program is not popular in NCR region. Students are opting for Government Institutions for M.Tech. Programs as their fee is low as compared with Private Institutions.

Observations made by the Governing Council are as follows:

- Prof. M. H. Dhananjaya, Advisor, JSS MVP suggested that to convert the M.Tech. Programs into blended learning programs.
- Re-engineering of the existing M.Tech. programs to ensure that they remain relevant keeping in view of the changing demands of society and Industry.
- Dr. B Suresh, Pro Chancellor, JSS AHE&R, Mysuru suggested that course credits must be completed and College could adjust the timing for classes to suit the candidates.

Dr. B Suresh, Pro Chancellor, JSS AHE&R, Mysuru opined that the website of the Academy is not providing complete information; e.g. fees details, laboratory facilities etc., and it is required to be more presentable.

Suggestions made by the Governing Council

- Website of the Academy should be more visible.
- UG and PG programs may be shown separately instead of Departments.
- Include the students of the Academy for updating the website of the Academy.

Resolution

- Website of the Academy is to be updated with more visibility within one month time and a report of the same is to be submitted to Executive Secretary and Director (A&A), JSSMVP, Mysore.
